YOUR MEMBERSHIP IN RETIREMENT

IF YOU ARE 55 OR OLDER...

CPA Australia maintains a list of members who are retired or working less than 15 hours or two days per week. If this describes you, you can maintain all the benefits of membership for a considerably reduced fee.

TO BE ELIGIBLE A MEMBER MUST:

- be aged 55 or older.
- no longer be engaged in full-time, gainful employment or business (other than minor part-time activities).
- no longer hold a specialist certificate.

To take up this benefit, apply online to be transferred to the Retired Member List.

IF YOU ARE 54 OR YOUNGER, WORKING PART-TIME OR NO LONGER WORKING...

...you may also be eligible for a reduction in your membership renewal fee.

This is not automatic; apply online for a reduction in your membership fee.
